- A. COVID-19 Recommendations-Discussed what information the South Central Health has suggested and what has been happening in the Magic Valley schools. After much discussion and concerns from the board and audience, Sarah Shields made a motion to cancel Parent/Teacher Conference and postpone Senior Project Open House. Seconded by Nikki Boekweg, motion passed unanimously. Joey Pittman made a motion to close school on March 17, 2020 and March 18, 2020 for students due to the COVID-19 concerns. Sarah Shields seconded, motion passed unanimously.
- B. Sale of Modular-Someone is interested in buying the modular at the elementary. We might want to hold on to the modular in case we need it during construction. We will keep it for now.
- C. Construction Management and/or Architect RFQ- Mr. Carson handed out a draft for the RFQ for the architect. The board decided that we would only need it for an engineer for the heating and air conditioning. Sarah Shields made a motion to send out an RFQ for an engineer for the heating and air conditioning at the elementary. Joe Ratto seconded and motion passed unanimously.
